## CHAPTER 21 PUBLIC COMMENTS AND RESPONSES

## 21.1 INTRODUCTION TO PUBLIC COMMENTS AND RESPONSES

As part of the NEPA/CEQA process, Santa Cruz County distributed the Revised Draft EIS/EIR and held a public open house in order to obtain comments on the document and the project from the public and other stakeholders. Chapter 21 includes all the comments received through this process. Three letters were received from agencies, three from organizations, and forty-seven from the public. Santa Cruz County has responded to every comment, and in some instances has revised the text of the EIS/EIR as part of that response. The index on the next page provides a key to locating these comments and responses.
